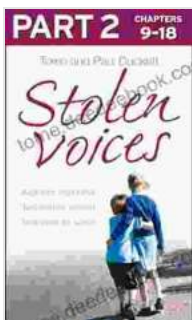


Sadistic Step Father: Two Children Violated Their Battle For Justice

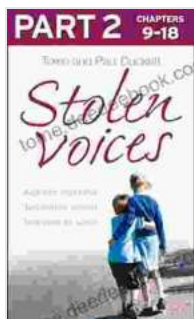

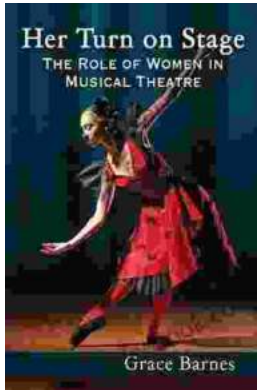

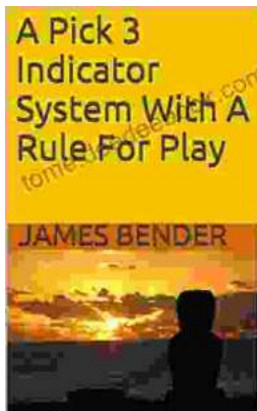
